Background

Our church here in Seend was built in about 1450 to serve the local community. It was built by a group of local benefactors, and has been supported by our community and congregation ever since. Over the centuries it has seen many changes meeting the needs of its people, but the current configuration was designed 100 years ago for services such as Matins, where people stayed in their pews, and children were not encouraged to come into Church at all.

What has been achieved

A mains water supply has been laid to the church to supply the new WC, the kitchenette and an outside tap.

At the front of the Church more space has been created for weddings, funerals and concerts by removing the front row of pews and raising the floor level. At the rear of the church some pews have been removed and the floor levels raised with ramps, to improve accessibility and create a space around the font for baptisms; for people to mingle after a service; and at other events. The beautiful new kitchenette/servery unit has been installed adjacent to this. This open area will also be available as a play space for the younger members of the congregation. Thanks to individual sponsors, stacking chairs have been provided to make up for the lost pew seating.

A fully accessible disabled friendly WC has been built in the NE corner of the churchyard which will be available during services and events. The level access via the south door of the church has also been improved by the installation of pathway lighting, which has also been extended to the WC.

It has been a long journey but what has been achieved is appropriate and befitting to a much loved and ancient church.

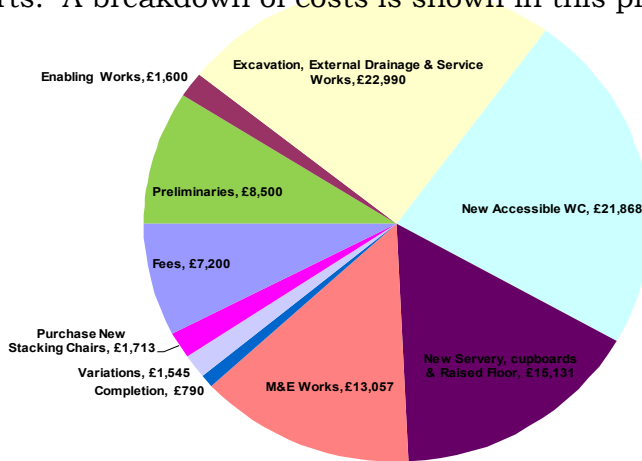

Costs

The original estimate for the proposed works was £130,000. The final cost is expected to be of the order of £120,000 depending on the VAT as some works are zero rated. We have already raised over 60% of this through donations, legacies, grants and other sums set aside for this purpose. The Salisbury Diocese have agreed to loan the outstanding sum whilst we continue fundraising efforts. A breakdown of costs is shown in this pie chart

*Gift Aid

The Government operates a **Gift Aid** scheme that allows charities to claim back the basic rate tax on every pound donated. The process is very simple - all you have to do is to complete the Gift Aid Declaration overleaf and we will do the rest.
